Notice for Second Admission Counseling

D.Ed. Special Education (HI/MR)

The provisionally selected candidates (**Confirmed List attached, herewith, as Annexure-I**) seeking admission to D.Ed. Special Education (HI/MR) are instructed to report on **31st July 2017 (10.00 am to 12.00 noon) for admission counseling**. No case of admission counseling would be entertained after the said dates and time. **Venue of the admission counseling** would be the **Room No. 306 (2nd floor)**, Academic Block-A2, University Main Campus, Mohaan Road, Lucknow (UP). In case, even after, counseling on 31st July, 2017 some seats are found vacant, candidates from **Waiting List II** (attached as **Annexure-II**) will be allowed for counseling on **1st August, 2017**. The candidates are necessarily required to bring following documents at the time of admission counseling:

1. Admit Card of the written examination;
2. Photo ID Proof;
3. Three passport size photographs;
4. Filled-in Admission Counseling Form (to be downloaded from the University Website)
5. Admission Fee (For Non-disabled candidate Rs.15,805 and disabled candidate Rs.10,305 would be submitted only through Bank Challan (Bank of Baroda) at DSMNRU Campus only after confirmation of admission by the respective Admission Committee;
6. Original Marks sheets and Certificates of 10th, 12th, Graduation, Post-Graduation (if any);
7. Migration Certificate;
8. Domicile Certificate, Caste Certificate, Disability Certificate (for those candidates who are seeking reservation in concerned area);
9. Print out of Application Form (who have submitted admission form online and did not send hard copy of the form to the University).
10. The basic eligibility to take admission in D.Ed. Spl.Edu-Regular (HI/MR) would be as per the latest norms of RCI and the University (DSMNRU)
